More than just running activities the House has tried to keep the community in touch and thanks are due to wonderful volunteers like Sandra Robertson and Judith Hughes for telephone calls, exchanges of books, recipes, knitting patterns and advice to those who were housebound. I would also like to thank Urban Harvest for keeping up the plant exchange table throughout the pandemic.

The House owes much to Sam who joined us as Admin Assistant and has fitted so well into her role – in particular for her skills in hauling our IT system into the 21st century; and thank you also Natalie for your assistance in the office during the brief time it was able to be open this year.

We have been kept financially viable through generous Federal and State grants, which will also help us rebuild once we can open up and we are very grateful for this assistance. The City of Whitehorse has also contributed through its funding and has kindly given us a grant to redevelop the old children's

playground into a sensory garden.

Thank you Julia, not only for managing our finances but ensuring that we understand them.

Throughout the year the Committee of Management has met monthly (via Zoom) to keep the governance of the House up to date and I would like to thank all of them for their wisdom and diligence.

She is the heart of this House: she has held everything together through lockdowns and brief reopening, she has kept us COVID safe; she has always been available to listen and to innovate. JUDITH BUCKINGHAM

MANAGER'S REPORT

The 2020 -2021 financial year has again been unpredictable and disruptive due to the effects of the COVID 19 pandemic. Going in and out of lockdowns has had a significant impact on the House's operations. However, we have managed to keep our community together by quickly reverting to Zoom classes where possible. These connections have had a positive effect on people's mental health and wellbeing and many of our participants have expressed their gratitude to be able to continue to engage with others during this time. We provided regular communication to all our members during the Pandemic and when we were able to open safely again at the beginning of term 1, 2021, people were keen to return. In term 1, up until the start of lockdown 4, we resumed all our regular programs at the House. The Dementia Café was expanding, and we ran additional classes in Chess, Piano, as well as all of our regular programs (over 30 each week). The Japanese language group and the Bahai youth group met at the House. However, we didn't run any other external bookings, to ensure the COVID safety of our participants. People quickly adapted to the COVID protocols of signing in, sanitising and wearing masks. The sense of joy in being back together in person was palpable and wonderful to witness.

It cannot be overstated that the need for social connection is extremely important during these times of uncertainty, particularly after such a long period in lockdown. The continuation of supportive and regular programs that are accessible to all, will be crucial for positive mental health outcomes. Neighbourhood Houses play a significant role in local communities to give people a place to meaningfully engage and connect with each other. During all the lockdowns, groups within the House continued to care for each other through regular zoom sessions, phone calls and messages. This has provided great support to our entire community and has assisted in developing long term friendships.

I am aware that coming out of the extended lockdowns, there will be a need for more social interactions to enable people to recover and re-connect with their community. Through the Neighbourhood House, I am programming more social activities to support this with activities such as drop-in coffee and chat sessions, the Repair Café, pop-up craft sessions, free talks on wellbeing, and a variety of one-off workshops. These activities will be free or low cost, so anyone can join in, reducing financial barriers. We have also received some funding from Council to develop the area at the rear of the House into a sensory garden (which had to be put on hold due to COVID), and I am looking forward to working on this project in the new year.

MANAGER'S REPORT

There has been a change in staffing at the House with Samantha Brown starting at the beginning of Term 1, 2021 as an Administrative Assistant. She brought her knowledge of marketing and social media and has developed a new website and online presence for the House. Val Kendall has moved to a volunteer role at the House, and I thank her for her ongoing support and assistance. I would like to thank Julia Wilson for her ongoing commitment and dedication as Bookkeeper and Natalie Ward, Judith Buckingham and Sandra Robertson for volunteering and giving their time and expertise working in the office.

As well as a new website <u>www.bhsnh.org.au</u> we have a new logo and are in the process of developing an on-line booking system which will streamline some of our enrolment processes. The next step will be to update our data base so we can quickly communicate with our tutors, participants and volunteers, particularly if we need to go in and out of lockdowns.

I would sincerely like to thank the Victorian and Federal Governments for all their assistance during this time, and the Whitehorse Council for their ongoing support.

I'd also like to thank the team at Neighbourhood Houses Victoria for keeping the sector updated on the many changes and challenges that have happened over the past year. The regular weekly updates, Professional Development Zoom sessions and forums have been invaluable.

MANAGER'S REPORT

NIECH and Whitehorse Community Houses Network

I have been on the NIECH committee for the past 7 years and I am the Committee secretary. The NIECH network has been very dynamic and engaging thanks to our networker Nikki Maddern. I would like to sincerely thank her for her guidance, information distribution and support during the pandemic. When I was a sole worker, working from home, it was critical to be able to access current, reliable and accurate sources of information.

Through a Be Connected Grant, organised by NIECH, we were able to provide three of our participants with Digital Devices to use during the lockdown. This enabled them to keep connected and engaged with the community during this time, and I thank Nikki for organising this.

The Whitehorse Community Houses network has continued to meet during the lockdown and has provided support and shared knowledge to House managers.

Finally, I would sincerely like to thank all the staff and Committee, tutors and group leaders at BHSNH for all their support and assistance during this year. Keeping our community together during the lockdowns has been a team effort and shows how remarkable and resilient the people of Box Hill South Neighbourhood House have been in these tough times. Many of our participants have expressed how grateful they have been to the House for keeping them socially connected and mentally well. It is a credit to all of us, and demonstrates how important Neighbourhood Houses are in our local community.

TREASURER'S REPORT

The House was closed for most of the 2020/2021 financial year with nearly all our classes and activities operating online through Zoom at little or no cost to our participants. However, our on-going financial commitments were all met. This would not have been possible without the support received through the government stimulus funding grants, and we are extremely grateful to those levels of Government that provided financial assistance during the pandemic.

Emerging from lockdown will no doubt continue to have an impact on our finances: density limits along with hesitancy to return to face to face activities will be challenges for some time. The BHSNH Committee of Management plan to use the 2020/2021 surplus to ensure that we can continue to support our community into the future. With our increased financial assets, we will be able to subsidise many of our classes and programs until they are once again self-sustaining, offering free or low-cost classes and events to keep the community engaged.

The pandemic has also highlighted our need to improve our current technology. Our dedicated office team have had to work with an outdated computer data base to contact all classes and participants during the pandemic: this has greatly increased their workload in providing communications and information to our community.

In closing I would like to convey my thanks to Pam and Julia. Pam has shown her expertise in identifying and applying for the Government grants that have formed the basis of our reported surplus. Julia has had the very difficult task of providing the accurate, underlying figures to qualify for the grants, and then accounting for this, especially when it meant we were going to post a large surplus for this financial year.



SANDRA ROBERTSON

FINANCE REPORT

The following is the unaudited financial report for BHSNH, 2020/2021. The accounts have been presented to Misa Le Vo, Finance Officer, Neighbourhood Houses Victoria, and have been reviewed. Our regular auditors, CBS Accounting have been unavailable despite our very best efforts to contact them.

We gratefully acknowledge the regular financial support of the Department of Families, Fairness and Housing Services, and the City of Whitehorse. We are also grateful for the State and Federal Government's financial assistance during the extended period of lockdown, during which the House was closed. The Job Keeper assistance program in 2020 subsidised our office staff wages to the extent of \$73,200, and if not for that assistance the House would have made a loss of \$36,899.

Although the House was in lockdown for the first six months of the 2020/21 financial year, thanks to Government financial assistance we made a profit of \$36,301 compared with a profit of \$5,885 for the 2019/20 financial year.

The Classes and Programs section of the House made a profit of \$1,605 for 2021/21 compared with \$10,921 for the previous financial year. Classes continued during lockdown via zoom where possible, and although the Tutors were paid at the normal rate, there were no participant fees charged during the first six months of the year. Face-to-face classes resumed in February 2021 and continued during Term 1. Term 2, 2021 was again subject to lockdowns and provision was made for class fee refunds.

Administration, being the section of the House bearing staff wages and all running costs, uncharacteristically had a surplus of \$23,716 compared with a loss of \$20,161 for 2019/20. The Job Keeper wages subsidy has been applied to this section. Due to the House being unoccupied for the greater part of the year, utilities costs were considerably reduced.

Other House Income for the year was reduced because the decision was made not to hire the House for birthday parties, as we felt we were unable to guarantee Covid safety. The income of \$8,027 for the year, reduced from \$16,281 for 2019/20, includes grants totaling \$4,000 and regular room hires while the House was operational. We were not able to hold our usual Devonshire Tea weekend or annual Art Exhibition.



WHITEHORSE URBAN HARVEST...

UMBRELLA DEMENTIA CAFE - CAFE OF CONNECTIONS

Umbrella Dementia Cafés provide welcoming peer support environments, psychosocial support, information, awareness and education for individuals, their families and the local community, so that people can remain connected to their community for as long as possible, with the aim of delaying the move to residential aged care living. UDC charity is funded by philanthropic foundations and provide a café coordinator to support this group and our BHSNH volunteers who support the cafés.

Throughout 2020/21, our relationships with Box Hill South Neighbourhood House has become stronger and very adaptable to our changing needs throughout the COVID pandemic. Together we are constantly sharing knowledge and providing support for our local communities impacted by dementia.

With Vicki Barnes leading the Café of Connections dementia café team, this group has remained connected and achieved the seemingly impossible by supporting all our volunteers and members experiencing dementia to use various online communication (including zoom) to continue our peer support work. To date, the Café of Connections group has enjoyed over 50 online cafes and 26 physical cafes at the BHSNH.





Our success can be attributed to the continuous teamwork and contribution of every single one of our volunteers who never gave up helping all our local Box Hill South couples experiencing dementia to get online & keep socialising, even when they themselves were facing significant adversity.

The Café of Connections will continue the group at the BHSNH in 2022 whether it be online or in person.
